The YEBO! PhD Portal gives students and teachers access to funding opportunities and makes it easier for them to take doctoral studies to the next level by making it an international experience! 2nd Training Session on "Towards institutional structures that support the complete PhD life cycle" Pretoria

26-29 March 2019

The starting point of this workshop is that internationalization of PhD studies is a shared institutional responsibility. In order to make each PhD experience more international institutions need to make sure that all phases of the PhD life cycle are adequately supported: before embarking on a PhD candidates need to have access to information and services with regard to funding and international mobility; their registration at the university should be free of any unnecessary barriers (e.g. a uniform registration system for all, incl. international candidates); upon registration they should have access to various services for personal/professional development, for short (e.g. conferences) and long term (e.g. research stays, joint supervision) international mobility; quality mechanisms are to be put in place to ensure retention of PhD students (e.g. annual progress reports, supervisor training, etc.).

Although the full PhD life cycle and all possible structures (on the institutional level as well as in the faculties) will be taken into consideration during the workshop, particular attention will be given to the following two topics: (1) structures/services (e.g. IROs) to support international mobility and collaboration on PhD level; (2) structures/services (e.g. Doctoral Schools) to enhance the international quality of the PhD research.

3rd Training Session on "Developing a Toolbox for Managing International Collaborative PhD programmes" Cape Town

24-28 June 2019

Integral to the internationalisation of PhD studies is the idea of student-supervisor interaction taking place across borders, nationalities and cultures. In addition, other stakeholders play a role when PhDs are internationalized. These stakeholders are located in different societal contexts, institutional contexts and strategies, disciplinary contexts and individual contexts. Given these different contexts, participation in the higher education system of different countries can sometimes mean that different and occasionally contradictory, norms, rules and regulations, legislative frameworks and educational traditions come into play. Indeed, this is true even at an inter-institutional level with in South Africa, let alone between countries.

There are therefore a number of important considerations to take into account in order to safeguard the interests of all parties. This training workshop will look in some detail at international PhD engagement through the mode of joint enrollment at different partner institutions. It will seek to map the elements that need consideration when contemplating enrolling PhDs in this way and aim to provide a template or guideline for South African partners to use. The training workshop will also look at some specific challenges that impact in the different contexts, from the macro to the micro level. In conclusion, the workshop will also allow for some alternative models of supervisory training to be shared since adequate supervisory capacity development in the country is a particular pressure point in the South African context.
